This agreement is entered into between Windy Creek Arabians, herein called STALLION OWNER, and \_\_\_\_\_, herein called MARE OWNER/LESSEE.

These parties agree as follows:

1. I, \_\_\_\_\_, hereby confirm my reservation to the Purebred Arabian Stallion, **Hy Wynds AHR# 624147** for the mare described below.
2. **\$750 Stud fee** is payable as follows: \$250 non-refundable booking fee to be submitted with signed contract. Half of the remaining \$500 will be paid prior to or at first collection. The remainder will be due no later than 30 days after insemination providing the mare has checked in foal. Payments will be made to: Donald or Angie Williby (Windy Creek Arabians), 20 Puckett Trail, Henderson, NC 27537.
3. **Transported Semen:** The mare owner/lessee is responsible for collection and shipment costs per shipment of semen. The stallion owner will provide the necessary contact information for the mare owner/lessee to make arrangements with the collection facility. The mare owner/lessee must contact the stallion owner and facility not more than 48 hours or less than 24 hours before semen will be shipped. Failure to do so may absolve stallion owner of any obligations under this contract. There will be an \$85 charge for the stallion to be hauled to the collection facility.
4. It is the mare owner/lessee's responsibility to have the mare examined by a licensed veterinarian prior to and during the mare's pregnancy and to keep the stallion owner notified of her status. If the mare has been previously bred she must have a clean culture prior to insemination. The stallion owner has the right to refuse service to any mare for any reason.
5. Should the mare not produce a live foal (first 72 hrs) that stands and nurses, the mare owner/lessee shall be entitled to a return breeding. If the foal dies for any reason, a statement of detail by a licensed veterinarian is required within 10 days of the foal's death. This clause is also binding in case of abortion. It will be necessary for mare owner/lessee to pay the additional collection/hauling fee's during the next breeding season.

6. If the mare is found to be barren and can no longer conceive the mare owner/lessee may substitute another mare. This contract is transferable with written permission between Windy Creek Arabians and mare owner/lessee and is good for the contract year signed and the next breeding year only.
